PGY2 Medication-Use Safety and Policy Residency

Program Purpose

The PGY2 Medication-Use Safety and Policy residency is a one-year training program that builds on the Doctor of Pharmacy (Pharm.D.) education and PGY1 pharmacy residency programs to contribute to the development of clinical pharmacists in advanced or specialized practice. This program is designed to provide residents with opportunities to function independently as practitioners by conceptualizing and integrating accumulated experience and knowledge and incorporating both into the provision of patient care that improves medication therapy. Residents who successfully complete this accredited PGY2 Medication-Use Safety and Policy residency program should possess competencies that qualify them for clinical pharmacist and/or faculty positions in drug information and drug use policy and position them to be eligible for attainment of board certification.

Program Structure

Residency program experiences include a combination of concentrated and longitudinal rotation experiences. Availability of experiences are as follows:

Small Project	Longitudinal (1 year = 3-5 hours/week*)	Required	N/A
Presentations/Education	Longitudinal (1 year = 2-5 hours/month* depending on conference schedule)	Required	N/A
